Guidelines for Filling up the Application Form for FIMI Environment Awards

1. The application form has three sections – A, B & C.
2. **Section-A** relates to general information about the applicant's organization and the mine site for which the application is specifically made.
3. (a) **Section-B** relates to compliance with all the applicable laws, acts and regulatory legal requirements. One may like to add further in respect of compliance with other acts or regulatory requirements for which no direct questions have been asked. An indicative list of Acts/Regulations is given in Appendix-I.
(b) Compliance with all the legal requirements (as per Section-B requirements) shall be the basic eligibility criteria for these Awards.
(c) Applicants are requested to fill Section-B carefully and factually.
4. (a) **Section-C** has two sub-divisions- Environment and Social. It comprises of questions, whose answers shall be assessed and evaluated as objectively as possible through a rigorous scoring system for short-listing the potential award winners.
(b) In the scoring system, each question shall carry a specific weightage.
(c) Answers of each question shall be evaluated on following attributes:
 - Leadership and commitment displayed
 - Resources (man, material & machines etc.) employed
 - Partnerships forged for leveraging requisite skills, knowledge etc.
 - Stakeholders engaged both internally and externally
 - Processes, procedures or mechanisms used to achieve results
 - Results achieved in terms of key performance indicators (key performance indicators may be cited by the applicants themselves)
 - Innovation done and key learnings retained within the organization
(d) Answers to each question in the Section-C, therefore, should be as comprehensive as possible and should be replete with supporting evidence, material to all the attributes listed above at point 4 (c).
(g) Do use additional sheets, wherever necessary and attach any additional documentation in support of your answers.
(h) Wherever years are not specified, information is asked for only last three years, i.e. 2006-07, 2007-08 and 2008-09.
5. For all the applicants that are short-listed for Awards, site visits shall be made for on-site assessment and verification purposes. Based on the site assessment, scoring shall be adjusted wherever justified.
6. Scores, with supportive evidences and justifications in respect of all the short- listed applicants shall be presented to the Members of Jury for selecting the Award Winners.
7. All the information and documentation provided by the applicants shall be kept strictly confidential and shall be used only for the purpose of selecting Award Winners.

8. Should there be a need to use any information provided by the applicants, it will only be used and put out in public domain only after obtaining written consent of the concerned applicant.
9. Each applicant shall be given objective and reasoned feedback confidentially as a value-addition for having participated in FIMI's Awards Schemes.
10. The Application Form duly filled in should accompany with a demand draft or cheque of Rs. 20,000/- (Rupees Twenty Thousand Only) in favour of 'Federation of Indian Mineral Industries' towards assessment-cum-evaluation fee.
11. In addition, all the short-listed applicants, for whom on-site assessment is an integral part of this process, shall have to bear actual travel, board, lodge and incidental expenses of the assessors.
12. Completed application forms, in all respects should reach the Federation of Indian Mineral Industries (FIMI) addressed to the Secretary General-FIMI, FIMI House, B-311, Okhla Industrial Area, Phase-I, New Delhi-110020, **by 08 March 2010**.
13. Application should be submitted in triplicate along with required supportive documents.
